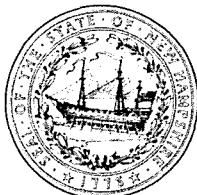

Staff has reviewed the filing received on February 2, 2015 in the above-captioned proceeding which also included DW 13-128 – Pittsfield Aqueduct Company, Inc. Compliance Tariff.

The recently submitted tariff pages for DW 13-126 – Pennichuck East Utility, Inc. Compliance Tariff have been submitted as NHPUC No. 6 – WATER. The current Tariff on file at the Commission is NHPUC No. 1 – WATER. Please make appropriate revisions to and then resubmit Supplements No. 9 and 10.

The recently submitted tariff pages for DW 13-130 – Pennichuck Water Works, Inc. Compliance Tariff have been submitted as Supplement No. 13. Due to a series of errors in 2012, when Tariff NHPUC No. 6 was filed and accepted, Supplements No. 11 and 12 were incorrectly accepted with the Tariff. Cancellation pages for NHPUC No. 6 Supplements No. 11 and 12 have since received by the Commission (December 5, 2012). Please see attached documentation. Puc 1603.03(b)(1) states "The tariff supplement itself shall be numbered serially and the pages therein shall be numbered consecutively;" Therefore, please resubmit the tariff pages associated with DW 13-130 – Pennichuck Water Works, Inc. Compliance Tariff as NHPUC No. 6 – WATER, Supplement No. 1.
