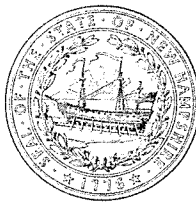

Springfield, VT in the Solar Farm Bank Aggregation Pursuant to RSA 362-F

Dear Mr. Hirsh:

On June 24, 2013, the Commission received an application from Solar Farm Bank LLC (Solar Farm Bank) requesting that the photovoltaic (PV) array at Ivek Corporation, 10 Fairbanks Road, North Springfield, Vermont, be certified as eligible to acquire New Hampshire Class II RECs and authorized to participate as a customer-sited source in the Solar Farm Bank aggregation. The Solar Farm Bank is certified by the Commission with certification code NH-II-13-010 and is recognized by the New England Power Pool Generation Information System under NON 35889.

The Ivek Corporation PV array is a customer-sited source as defined in the Commission's regulations at N.H. Admin. Rules Puc 2502.13. Pursuant to N.H. Admin. Rules Puc 2505.01(f), "[n]o customer-sited source shall be certified as eligible to acquire certificates under this part unless the source is located in New Hampshire." This rule implements the statutory restriction set forth in RSA 362-F:6, II.

Accordingly, the Commission has denied the request for Ivek Corporation's PV array to be certified as eligible to obtain New Hampshire Class II RECs and to be authorized to participate in the Solar Farm Bank aggregation.
