- Added Section information to several pages
- Added Page 29B – Directory Assistance Call Connect Service (This page effective March 27, 2003 is posted on FairPoint’s website, but missing on the New Hampshire Public Utilities Commission’s website.)
- Moved Custom Calling Plus Features from page 30A to page 29C
- Changed numbering on page 35 to match the numbering in the tariff
- Added page 35A – first page of Centrex services was missing
- Made Centrex service in Section “O” to match the format of Section 5
- Added headers to several pages in Section “O”
- Moved text from the top of page 37 to the bottom of page 36
- Moved text from the top of page 40 to the bottom of page 39
