On July 29, 2013, America Approved Commercial, LLC (America Approved) filed an application with the Commission to register as a provider of electric aggregation service. On August 8, 2013, America Approved provided additional information for its application. Staff reviewed all information filed and determined that the application is complete.

The Commission approves your application to register as a provider of electric aggregation service, effective August 9, 2013. The registration is for a term of 2 years and expires at the end of business on August 8, 2015. Pursuant to N.H. Code Admin. Rule Puc 2003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before June 9, 2015.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin.
