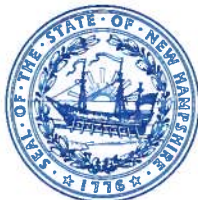

Assented-to Motion for an Extension of Time to File Sewer Tariff

Dear Ms. Holahan:

On March 13, 2014, you filed a motion for an extension of time to file a sewer tariff in the above-referenced proceeding. Section IV (E) of the settlement agreement approved in that proceeding provides that within 60 days of the Commission's approval of the settlement, Abenaki will file a revised tariff setting forth the terms and conditions relating to the provision of sewer service to its customers in Belmont. The 60 day deadline expires today, March 17, 2014.

Abenaki filed its motion to extend the deadline until March 28, 2014, because the person responsible for approving the revised tariff has been out of the country attending to a family medical situation. All other parties to this docket assented to the motion.

The Commission may extend a deadline when the "party making the request has demonstrated that circumstances would cause undue hardship or inconvenience unless the request were granted and [that] extension would not unduly delay the proceeding or adversely affect the rights of any party." Puc 202.04(c). The Commission finds that Abenaki has met the standards of Puc 202.04(c) and grants its request. Accordingly, the revised tariff shall be filed on or before March 28, 2014.
