On September 20, 2013, the Commission held a prehearing conference in the above-captioned matter. Present were Staff, the Office of Consumer Advocate (OCA), and the State's electric and natural gas distribution utilities which, in its order of notice, the Commission made mandatory parties to this proceeding, i.e., Public Service Company of New Hampshire, the New Hampshire Electric Cooperative, Inc., Northern Utilities, Inc., Unitil Energy Systems, Inc., Granite State Electric Company, and EnergyNorth Natural Gas, Inc.

Also present were the following parties that requested intervenor status, which motions the Commission granted: North American Power and Gas, LLC, Electricity N.H., LLC d/b/a E.N.H. Power, the Retail Energy Supply Association, and PNE Energy Supply, LLC.

The parties and Staff met in a technical session following the prehearing conference and developed the following proposed procedural schedule for the Commission's consideration and approval:

Staff respectfully requests that the Commission approve the proposed procedural schedule.

At the prehearing conference, Staff said that the docket concerned both payment hierarchy between distribution utility and competitive supplier, and communication with and clarity for customers who take competitive supply and receive collection calls from both the distribution utility and the competitive supplier. At the technical session, North American Power and Gas, LLC, and the Retail Energy Supply Association said that they believed the payment hierarchy issue could be resolved through settlement discussions outside of the procedural schedule. The parties will inform the Commission if settlement occurs and request appropriate revisions to the procedural schedule.

Finally, Staff notes that the Commission heard positions of the parties at the prehearing conference regarding whether the gas distribution utilities should be mandatory parties to this proceeding, but did not render a decision regarding the matter at that time.
