Dear Mr. Ginn:

On September 15, 2014, Union Atlantic Electricity (Union Atlantic), a competitive electric power supplier currently authorized to provide service in the franchise areas of Public Service Company of New Hampshire and New Hampshire Electric Cooperative filed a request to expand its service area to include the franchise area of Liberty Utilities. With its filing, Union Atlantic included a copy of a certificate demonstrating it had completed electronic data interchange (EDI) testing with Liberty Utilities.

Staff reviewed the filing and recommended the Commission approve the request, in a memorandum filed on September 15, 2014. The Commission has reviewed Union Atlantic's filing and Staff's recommendation, and has approved Union Atlantic's request. Accordingly, Union Atlantic is authorized to expand its service area to include the franchise area of Liberty Utilities, effective as of the date of this letter.
