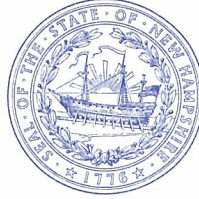

To the Parties:

On December 10, 2013, a duly noticed prehearing conference was held in the above referenced proceeding. Appearances at the prehearing conference were entered by representatives of Public Service Company of New Hampshire, the City of Manchester, and Commission Staff. The Office of Consumer Advocate has a statutory right to intervene in the proceeding but chose not to at this time. A motion to intervene by the City of Manchester was granted.
