RE: DG 13-251 EnergyNorth Natural Gas, Inc. 2013-2014 Winter Period Cost of Gas – January 2014 Trigger

Dear Ms. Howland:

On behalf of EnergyNorth Natural Gas, Inc. d/b/a Liberty Utilities (the "Company") and in accordance with New Hampshire Public Utilities Commission Order No. 25,591, dated October 31, 2013 in DG 13-251, I enclose an original and two copies of tariff pages 1, 3, 76, and 87, effective January 1, 2014. These adjusted rates require no further Commission action because they are within the maximum rates set forth in Order No. 25,591. Also enclosed is the Company's current calculation of its projected over or under collection of gas costs for the 2013-2014 winter season ending April 30, 2014.

For November and December 2013, the calculation reflects the actual NYMEX settled price. For January through April 2014, the calculation reflects the 15-day average NYMEX closing prices as of December 18, 2013. The resulting projected under collection of \$6,859,643 is approximately 9.86% of the total anticipated gas costs for the 2013/14 winter season. Accordingly, the Company elects a rate change effective January 1, 2014, and therefore, has attached revised tariff pages.

The cost of gas rates are summarized in the following table.
