Dear Director Howland:

Enclosed please find Public Service Company of New Hampshire dba Eversource Energy's reconciliation of Stranded Cost Recovery Charge (SCRC) and Energy Service (ES) revenues and expenses for the period October 1, 2014 through December 30, 2014. In the Stipulation and Settlement filed in Docket No. DE 02-127, PSNH, the Office of Consumer Advocate (OCA) and Staff agreed that PSNH dba Eversource Energy would make preliminary quarterly filings reconciling SCRC and ES revenues and expenses.

The preliminary results for the fourth quarter of 2014 indicate the following:

- (1) The SCRC expenses have exceeded SCRC revenues resulting in an under recovery of approximately \$9.7 million, as shown on page 1 of the attached filing.
- (2) The ES expenses exceeded ES revenues (including Merrimack Scrubber) resulting in an under recovery of approximately \$8.2 million, as shown on page 6 of the attached filing.
