Dear Ms. Lakritz:

On January 6, 2014, the Commission received applications from Knollwood Energy of MA, LLC¹ (Knollwood Energy) requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the following entities' photovoltaic (PV) arrays pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law:² Mikel Myers (Myers); Michael McGuire (McGuire); and, Northland Forest Products.

The Commission, in a non-adjudicative process, is required to issue a determination of whether a facility meets a particular classification within 45 days of receipt of a completed application. The above-named facilities are customer-sited sources and meet the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the applications Staff recommends Commission approval for the Myers, McGuire, and Northland Forest Products as eligible Class II facilities to be included in the Knollwood Energy aggregation, effective as of January 6, 2013.

Since these facilities are customer-sited sources, their output is not recorded in the ISO New England Market Settlement System and, as a result must be monitored and verified by an independent monitor. The applications for Myers and McGuire list Thomas Kelly Natural Capital, LLC, as the independent monitor; the Northland Forest Products application lists Paul Button, Energy Audits Unlimited. The independent monitors responsibility is to verify the facility's output pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr.

¹ The Commission approved Knollwood Energy of MA, LLC as an aggregator of RECs on November 12, 2013, DE 13-256.

² Class II eligibility requires a facility to produce electricity from solar technologies that began operation after January 1, 2006 (RSA 362-F:4, II).


Kelly and Mr. Button will report these facilities' total output annually to the customer and to the Commission. The monthly output will be reported quarterly to the NEPOOL Generation Information System as part of Knollwood Energy's Class II aggregation pursuant to Puc 2505.09(h)(3). The GIS facility code for Myers is NON 38908; McGuire's GIS facility code is NON 38909; and, Northland's is NON 38907.

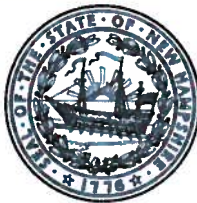

Please be advised that, pursuant to RSA 362-F, the New Hampshire Public Utilities Commission has certified the Mikel Myers (Myers), Michael McGuire (McGuire) and Northland Forest Products photovoltaic facilities as part of the Knollwood Energy of MA, LLC (Knollwood Energy) aggregation.
