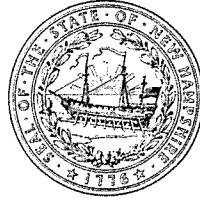

Dear Mr. Cesarez:

Pursuant to Puc 2503.03(a) and RSA 362-F:8, competitive electric power suppliers were required to file a Form E-2500 Annual Renewable Portfolio Standard (RPS) Compliance Report or an equivalent annual report (Annual Report) with respect to the 2014 compliance year on or before July 1, 2015. Under Puc 2503.03(b) and RSA 362-F:10, II, the full amount of any alternative compliance payments (ACP) due with respect to compliance year 2014 was required to be paid to the New Hampshire Public Utilities Commission (PUC) at the same time as the filing of the Annual Report, on or before July 1, 2015, either with a check made payable to the State of New Hampshire or through electronic transfer to the renewable energy fund bank account. To date, however, neither the required Annual Report nor the required ACP has been received from Ambit Northeast, LLC d/b/a Ambit Energy (Ambit).

Please file the required Annual Report and pay the full ACP amount within ten (10) days of the date of this letter. If full payment is not received by such date, then the Ambit ACP account balance may be referred for collection to the New Hampshire Department of Justice. In addition, the Commission may initiate an adjudicative proceeding to impose penalty sanctions of up to \$1,000 per day for each violation of an applicable state statute, pursuant to Puc 2005.01(b).
