**Re: DM 14-005 Ambit Northeast, LLC – Recognition and Use of Certain 2017
New Hampshire Class III Renewable Energy Certificates**

Dear Mr. Nix:

On July 2, 2018, Ambit Northeast, LLC (Ambit) filed its Renewable Portfolio Standard (RPS) compliance report for 2017. Following the report filing, Ambit requested that 2,800 Renewable Energy Certificates (RECs) which are certified as both Connecticut Class I and New Hampshire Class III, and were retired in its Connecticut GIS subaccount, be available for use in New Hampshire for RPS compliance.


Ambit filed a motion with the Connecticut Public Utilities Regulatory Authority (CT PURA) stating that it had inadvertently retired 2,800 RECs in the Connecticut GIS subaccount and seeking approval to use those RECs for its 2017 New Hampshire RPS compliance. On August 6, 2018, Ambit provided a copy of an approval letter issued by the CT PURA authorizing the release of the 2,800 RECs for the sole purpose of meeting Ambit's New Hampshire RPS compliance. The specific details of the 2,800 Class RECs at issue are provided below:

Unit Name: Hemphill 1
State: NH
Fuel Type: Wood
Month of Production: 2017/12
Certificate Serial Number: 1922875 – 1596 to 4395

The Commission has reviewed Ambit's request and has approved the use of the specified RECs retired in Ambit's GIS Connecticut subaccount for compliance with its 2017 New Hampshire RPS obligations. Ambit cannot sell, retire, claim, or represent as part of electrical energy output or sales or use those specified RECs to satisfy obligations in any other jurisdiction.

This decision regarding the aforementioned RECs shall not be regarded as establishing a precedent, and the Commission may deny any similar requests from Ambit or any other electricity provider in the future.
