Please be advised that the New Hampshire Public Utilities Commission has certified the 125 megawatt (MW) Cohocton Wind Plant (Cohocton Wind), owned by Canandaigua Power Partners, LLC, as a Class I renewable energy source, effective as of March 13, 2014, pursuant to RSA 362-F:4, New Hampshire's Electric Renewable Portfolio Standard law. Accordingly, Cohocton Wind is eligible to be issued New Hampshire Class I RECs as of such date, provided that certain additional confirmatory information is submitted to the Commission following the end of each calendar quarter.

The Cohocton Wind project, located in Cohocton, New York, is comprised of (50) Clipper 2.5 MW wind turbine generators. The initial date of operation of the wind project was January 27, 2009. Copies of the Town of Cohocton Planning Board State Environmental Quality Review Findings Statements provided assurance that the Cohocton Wind facility is permitted in the State of New York.

The GIS facility code is IMP 32827. The New Hampshire Renewable Portfolio Standard certification code for Cohocton Wind is NH-I-14-042.
