On March 14, 2014, the Commission received an application for Class II New Hampshire Renewable Energy Certificate (REC) eligibility for the photovoltaic (PV) array at the Gorham residence of Dennis Pednault (Pednault). A letter from Revolution Energy Aggregation, LLC (REA) requesting the Pednault facility's participation in the REA aggregation was received April 14, 2014. The REA letter completed the application.

The above-named facility is a customer-sited source and meets the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the application Staff recommends that the Commission approve the Pednault PV array as part of the REA's Class II aggregation effective April 14, 2014.

Since this facility is a customer-sited source, its output is not recorded in the ISO New England Market Settlement System and, as a result must be monitored and verified by an independent monitor. Paul Button of Energy Audits Unlimited will serve as the independent monitor pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report the facility's total output quarterly to the NEPOOL Generation Information System as part of REA's Class II aggregation pursuant to Puc 2505.09(h)(3). The GIS facility code assigned to REA is NON 15299.
