On March 24, 2014, the Commission received an application filed by Knollwood Energy of MA, LLC¹ (Knollwood Energy) for the Dan Watts (Watts) residential photovoltaic (PV) facility. Information required to complete the application was received May 5, 2014, in an email correspondence from Michael Motta of Public Service Company of New Hampshire (PSNH). Additional applications were received from Knollwood on April 11, 2014, for Barrington Power, Rochester Truck Repair (Rochester Truck Repair); Barrington Power, White Mountain Pools, (White Mountain Pools); Richard Binder (Binder); and, Harry O Electrical Corporation (Harry O Electrical). The Rochester Truck Repair, White Mountain Pools, Binder, and Harry O Electrical applications were complete as submitted.

Knollwood Energy is requesting Class II New Hampshire Renewable Energy Certificate (REC) eligibility for these entities' photovoltaic (PV) arrays pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law<sup>2</sup> and inclusion in the Knollwood Energy aggregation.

The above-named facilities are customer-sited sources and meet the Class II eligibility requirements under RSA 362-F:4, II. Based on review of the applications, Staff recommended

Commission approval for the Watts, Rochester Truck Repair, White Mountain Pools, Binder, and Harry O Electrical PV facilities as eligible Class II facilities to be included in the Knollwood Energy aggregation. The Watts PV facility is eligible effective May 5, 2014; Rochester Truck Repair, White Mountain Pools, Binder, and Harry O Electrical facilities are eligible Class II facilities to be included in the Knollwood Energy aggregation, effective as of April 11, 2014.

Because these facilities are customer-sited sources, their output is not recorded in the ISO New England Market Settlement System and, as a result, must be monitored and verified by an independent monitor. The applications list Paul Button of Energy Audits Unlimited as the independent monitor for all of these facilities. The independent monitor's responsibility is to verify the facility's output pursuant to N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. Mr. Button will report these facilities' total output annually to the customer and to the Commission. The monthly output will be reported quarterly to the NEPOOL Generation Information System as part of Knollwood Energy's Class II aggregation pursuant to Puc 2505.09(h)(3).
