Complaint Against FairPoint Communications, Inc. re: Rate Increase Dispute

STATEMENT OF POSITION ADDRESSING COMMISSION QUESTIONS

In accordance with the New Hampshire Public Utilities Commission's ("Commission")

Order of Notice dated April 15, 2014, Northern New England Telephone Operations LLC d/b/a

FairPoint Communications - NNE ("FairPoint") responds as follows to the Commission's

specific questions:

Q1: In the event Mr. Whalen discontinued either one of the two lines to his home, would FairPoint consider the remaining line, basic service?

A1: Yes, pursuant to RSA 374:22-p, (b) (1), qualifying single line voice service described in

FairPoint's NH Catalog is considered basic. In the event that one of the two lines at the Whalen's

residence was to be disconnected, then the other line therefore could be, and from FairPoint's

perspective would be, considered basic.¹

Q2: If FairPoint would not consider either of these lines basic service if the other were discontinued, please identify each and every reason why the line, would not, in FairPoint's opinion, be basic service.

A2: See response to the preceding question.

Q3: Identify on your publically available website the rates, fares, charges prices and terms and conditions of basic service are described, pursuant to RSA 378:1-a.

- Under the New Hampshire Retail Catalogs heading, to locate information for rates, fares, charges, and prices for basic services as well as related service terms and conditions, click on New Hampshire Catalog Part A, Section 1 (Page 4), New Hampshire Catalog Part M, Section 1 (specifically, Section 1.5.1, pages 16 17.1; Section 1.5.3, pages 19, 20; and Section 1.5.4, page 20).
