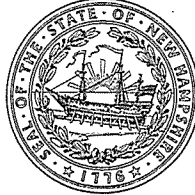

On April 28, 2014, TDL Energy Solutions filed an application with the Commission to register as a provider of natural gas aggregation service. Staff reviewed the application and determined that it is complete.

The Commission approves your application effective May 7, 2014. The registration is for a term of 2 years and expires at the end of business on May 6, 2016. Pursuant to N.H. Code Admin. Rules Puc 3003.02(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before March 5, 2016.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin.
