Dear Ms. Thomas:

On May 30, 2014, Northern New England Telephone Operations, LLC, d/b/a FairPoint Communications (FairPoint), submitted a filing to revise its intrastate access tariff for effect on July 1, 2014, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order). On June 30, 2014, FairPoint filed additional revisions to two pages of its intrastate access tariff as agreed upon with Staff. Consistent with the Transformation Order as revised, these tariff filings propose to set FairPoint's intrastate access rates equal to its current interstate rates.

Staff reviewed the proposed FairPoint tariff changes for compliance with FCC orders and rules, and following its investigation, recommended that these proposed changes be allowed to go into effect on July 1, 2014 as proposed.

The Commission has accepted Staff's recommendation that the proposed tariff changes be allowed to take effect. For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed tariff changes, filed on May 30, 2014 and June 30, 2014, are effective, as proposed, on July 1, 2014. Tariff pages should be filed referencing Docket No. DT 14-146 and reflecting the effective date of July 1, 2014.
