On July 2, 2014, Northland Telephone Company of Maine, Inc. d/b/a FairPoint Communications (FairPoint) filed revised tariff pages to make certain changes to the nonrecurring charge when a customer adds a Custom Calling Feature. It would also change the name of Central Office Work Charge to Central Office Connection Charge. On July 30, 2014, FairPoint submitted a letter withdrawing the tariff filing stating that would like to add other administrative changes to the tariff pages and will resubmit them at a later date.
