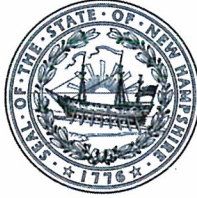

To the Parties:

On October 24, 2014, the Commission issued Order No. 25,727 on a *nisi* basis granting PSNH license to construct and maintain electric lines and static wires over and across the Ammonoosuc River west of Industrial Park Road in Littleton, New Hampshire. As a condition of the order *nisi*, PSNH was required to cause a summary of the order to be published no later than November 3, 2014, or the order would not become effective.

On November 3, PSNH informed the Commission that it would not publish the summary as required and requested that Order NISI No. 25,727 be withdrawn. By its own terms, Order No. 25,727 shall not take effect. Accordingly, Docket No. DE 14-195 is hereby closed.
