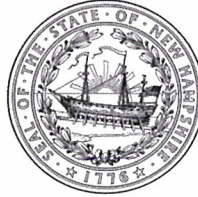

On July 9, 2015, the Commission held a duly noticed prehearing conference in the above referenced matter. An intervention request of State Representative, Howard Moffett was granted at the prehearing conference.
