

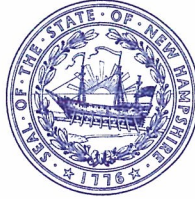

Settling Staff Request for Update by La Capra Associates

Dear Attorney Speidel:

Following yesterday's technical session and deposition of the La Capra witnesses, Dick Hahn and Dan Koehler, Settling Staff would like to request two updated figures from the earlier March 31, 2014 PSNH Generation Asset and PPS Valuation Report (2014 La Capra Report).

Updated LMP electric rate forecasts for NH based on the markets adjustments discussed in the 2015 update, including:

- Updated Confidential Figure 4 – NH LMP as shown on page 29 of the La Capra Report
- Updated Confidential Figure 8 – FCM Price Forecast as shown on page 33 of the La Capra Report

Mr. Hahn, during questioning yesterday, indicated that these two items could be done quickly and without much effort. We believe that Figure 8 (referenced above) is merely the table form of the graphic shown as Figure 1 on page 7 of the 2015 La Capra update. We believe that Figure 4 (referenced above) may be derived based upon a manual adjustment to Figure 2 on page 8 of the 2015 La Capra update. As a result, we request that Non-Advocate Staff instruct the La Capra witnesses to perform these two updates.

Thank you for your assistance in this matter. We would appreciate receipt of these two items prior to our rebuttal testimony deadline on November 16, 2015.
