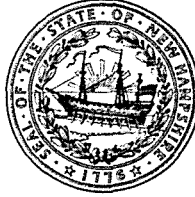

Dear Mr. McNeil:

On December 9, 2014, the Commission received applications filed by the New Hampshire Electric Cooperative (NHEC) requesting Class II eligibility for NHEC member photovoltaic (PV) arrays and inclusion in the NHEC aggregation. The applicants include Sara Goodman (Goodman), Sterling Moffat (Moffat), Philip LaMoreaux (LaMoreaux), Cheryl Smith (Smith), Louis S. Abdu (Abdu), Margaret Yatsevitch<sup>1</sup> (Yatsevitch (2)) and Elliott Markow (Markow).

Staff has reviewed these applications and has recommended approval of these PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation as listed in the following table:



These facilities are customer-sited sources. Their output is reported as part of the NHEC aggregation to the New England Power Pool Generation Information System (NEPOOL-GIS) as NON32900. In addition to reporting each source's output to the Commission, NHEC will include the total output of these facilities when it reports the total output of all of its Class II eligible facilities, under the name *NHEC Class II Aggregation*, to the NEPOOL-GIS. NHEC also serves as the Independent Monitor for these sources.

The Commission has determined that NHEC has provided all the information necessary to demonstrate these facilities' eligibility for certification and hereby certifies the above named PV arrays as eligible for Class II RECs and inclusion in the NHEC aggregation effective as of the dates listed in the table above.

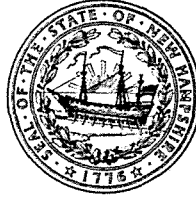


