Staff Recommendation to Accept Agreement and Close Docket

Dear Ms. Howland:

On February 10, 2015, Rosebrook Water Company, Inc. (Rosebrook) filed an affiliate agreement with the Commission pursuant to RSA 366:3¹. This agreement is for the provision of management and administrative services by Rosebrook to Resort Waste Services Corporation (Resort Waste), a related party. This agreement was effective January 1, 2015. It replaces an affiliate agreement dated January 1, 2013, which was effective for calendar year 2013 and renewed under its terms for 2014.

Under this agreement, Rosebrook provides management, accounting, and customer relations services to Resort Waste. This agreement will net Rosebrook \$95,112 annually or \$7,926 per month in payment for the services provided. Upon request, Rosebrook provided Staff with an analysis of its costs used as the basis for the monthly charge. The agreement is for services provided in calendar year 2015, and will automatically renew unless there is 90 day notice provided by either party.

Since all costs of a public utility can be reviewed by the Commission in rate proceedings, Staff recommends the Commission accept this filing and close this docket.
