

AFFIDAVIT OF COMPLIANCE AND PUBLICATION

NOW COMES Susan S. Geiger, upon oath, being duly sworn, and states as follows:

1. In accordance with the Order *Nisi* Granting License (Order No. 25, 776) issued in the above-captioned docket on April 8, 2015, on behalf of NH-Big Island Co., I caused the summary of said Order to be published once in a statewide newspaper of general circulation no later than April 13, 2015. Said publication was made in the Manchester Union Leader on April 10, 2015. *See attached copy.*

2. In accordance with the above-referenced Order *Nisi*, I caused a copy of said Order *Nisi* to be sent by first class mail no later than April 13, 2015 to: (i) Ms. Mary Reynolds, City Clerk of Laconia, New Hampshire; (ii) New Hampshire Attorney General Joseph Foster; (iii) Beach Club Condominium, the owner of land bordering Lake Winnepesaukee at the location of the crossing (a copy was also sent by USPS overnight delivery); (iv) the New Hampshire Department of Transportation; and (v) the New Hampshire Department of Transportation.

3. The mailing to Beach Club Condominium was sent to a post office box that was listed on the Laconia Tax Map for the relevant property (i.e. the land bordering Lake Winnepesaukee at the location of the crossing).

4. On the afternoon of April 14, 2015, I received a phone call from the Laconia Post Office indicating that the post office box to which the Beach Club Condominium mailing was made was closed. Upon receiving this notification, I immediately contacted representatives of NH-Big Island Co. in an effort to obtain a correct address for Beach Club Condominium.

5. On the evening of April 14, 2015, NH-Big Island Co.'s engineer, Mr. Peter Howard, instructed me to send a copy of said Order *Nisi* to Mr. Jay Spadaro, President of Beach Club Condominium at Mr. Spadaro's home address, 32 Arlene Drive, Pelham, NH 03076.

6. I cause a copy of the Order *Nisi* to be sent on April 15, 2015 by overnight mail to Mr. Spadaro at the above-referenced address.

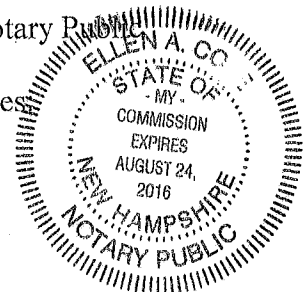



Summary of Order *Nisi* No. 25,776
Granting Water and Land
Crossing License
April 8, 2015

On April 8, 2015, the Commission approved a petition filed by NH-Big Island Co. requesting authority to construct and maintain an electric cable, an internet and television cable, a water pipeline, and a sewer pipeline beneath a state-owned railroad and beneath Lake Winnepesaukee to serve Big Island in the City of Laconia, New Hampshire. The petition explained that each of the lines and pipes will be in separate sleeves, which will be bundled together as they travel approximately 12 feet under the lake bed between shore and Big Island.

Staff recommended that the Commission grant the license subject to certain conditions requiring compliance with applicable safety standards, construction requirements, and permits.

The petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Commission, are posted to the Commission's website at <http://www.puc.nh.gov>.

The Commission granted NH-Big Island's request for a license to cross public waters and lands by order nisi dated April 8, 2015, subject to Staff's proposed conditions. To ensure that all interested persons receive notice of this docket and have an opportunity to request a hearing, the Commission delayed the effectiveness of its approval until April 20, 2015. All persons interested in responding to the Commission's approval may submit their comments or file a written request for a hearing, which states the reason and basis for a hearing, no later than April 15, 2015. Any person interested in responding to any such comment or request for hearing shall do so no later than April 17, 2015. Following consideration of any comments and requests for hearing received, the Commission may further extend the final effective date of its approval. The Commission's approval shall otherwise become final and effective on April 20, 2015, unless the Commission orders otherwise.
