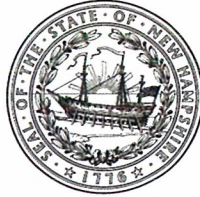

To the Parties:

The Commission held a prehearing conference in the above referenced matter on May 6, 2015. Appearances were entered by Freedom Logistics, LLC d/b/a Freedom Energy Logistics (Freedom), Granite State Hydropower Association (GSHA), Liberty Utilities (Granite State Electric) d/b/a Liberty Utilities (Liberty), Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource), the Office of Consumer Advocate (OCA), and Commission Staff (Staff). Fiske Hydro was also present as a witness through Freedom's counsel, but is not a party to the docket.


The Commission's attorney, Rorie Patterson, Esq., presided as the Hearings Examiner and, on May 12, 2015, filed a report summarizing her recommendations on the petitions to intervene. The petitioners to intervene were: Eversource, Liberty, GSHA and Unitil Energy Systems, Inc. (Unitil). Unitil filed a motion to intervene but was not present at the prehearing conference. There were no objects to the petitions to intervene. The Commission has granted the petitions to intervene.

Following the prehearing conference, the parties, the OCA, and Staff met in a technical session and agreed upon the following schedule, which Staff submitted to the Commission by letter dated May 8, 2015:
