To the Parties:

On June 22, 2015, NhSolarGarden.com LLC (NhSolarGarden) filed a petition to intervene in this docket, and on July 28, 2015, Borrego Solar Systems, Inc. (Borrego), filed a petition to intervene. No one objected to either petition. The Commission has granted NhSolarGarden's and Borrego's petitions to intervene pursuant to RSA541-A:32, II. The Commission urges NhSolarGarden and Borrego to coordinate their participation in this case with other parties to the extent possible.

In light of Order No. 25,810 (Sept. 8, 2015) denying Eversource's motion to reconsider, the Commission directs the parties to file a proposed procedural schedule to return this docket to a track that will lead to a hearing. The parties shall file a proposed schedule within 10 days.
