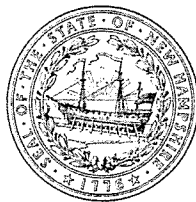

Dear Ms. Moroz:

On December 10, 2015, Mint Energy, LLC (Mint Energy), a registered competitive electric power supplier, filed a request to the Commission for authorization to serve residential customers, and included with such request a proposed sample contract for residential customers, referred to as its "Energy Lock" contract.

Commission Staff (Staff) filed a memorandum on December 11, 2015, stating it had reviewed the "Energy Lock" contract form and had found it not to be inconsistent with the consumer protection requirements set forth in N.H. Code Admin. Rules Puc 2004, and recommending that the Commission approve Mint Energy's request to serve residential customers.

The Commission has reviewed Staff's memorandum and approved its recommendations. Accordingly, Mint Energy is authorized to serve residential customers.
