CERTIFICATE (REC) ELIGIBILITY**

The Commission received and staff reviewed the application requesting Class IV REC eligibility for the Steels Pond Hydroelectric facility owned by the State of New Hampshire and operated by Lori D. Barg, Steels Pond Hydro, Inc. Based on Staff's recommendation, the Commission has approved the 0.300 megawatt facility as eligible for Class IV RECs,¹ effective as of April 1, 2015.
