The Commission has issued the following record request in the above captioned docket and directs Liberty to file a response with the Commission and serve on the parties to this docket by 4:30 p.m., Wednesday, July 27, 2016. The Commission, pursuant to Puc 203.30, reopens the record for the limited purpose of admitting this response by Liberty as Exhibit 12.

Record Request

Reference: Electric Attachment A, page 7 of 10, April 26, 2016 (Bates 23) of the Settlement Agreement. This attachment shows the monthly bill impacts resulting from changes in System Benefits Charges for Liberty. For instance, for the year 2017, the attachment shows a bill impact of \$0.67 per month for Residential Rate D. However, the data shown on this attachment appears to develop a bill impact of only \$0.32 per month (i.e., $\$0.00381 - \$0.00330 \times 625 = \$0.32$).

- a. Please explain this variance. Please include in your response, if appropriate, an updated attachment that shows any corrections to the Residential Rate D for the years 2017 through 2020.
- b. Also, with respect to the General Service Rate G-2, check the monthly bill impact calculations for the years 2017 through 2020 and, if appropriate, please provide any corrections.
