Dear Ms. Sanders:

On July 16, 2015, Charter Fiberlink-NH CCO, LLC (Charter) submitted a filing described as an "Intrastate Access Services Rate Schedule pursuant to Charter's Certificate of Authorization to provide service under Authorization No. 09-016-04."

We appreciate your effort to provide transparency in access rates. However, as we discussed last year, New Hampshire laws regarding tariffs apply only to filings made by authorized public utilities.

Authorizations to provide utility telephone service issued by the Commission in previous years have expired pursuant to Puc 404.01(f). Only those companies currently operating as telephone utilities, in particular by providing non-VoIP and non-IP-enabled voice service to end users, were issued new certifications as telephone utilities.

In light of this, Staff will not act upon this filing.
