Enclosed for filing by Lighttower Fiber Networks I, LLC and Lighttower Fiber Networks II, LLC (collectively, "Lighttower") are revised versions of the four crossings lists that Lighttower previously filed on or about June 1, 2015. Lighttower has reorganized and reformatted these lists in an attempt to make them clearer and more understandable. In the case of the Water Bodies Layer and Land Use Layer lists, Lighttower has reformatted the listings so that each crossing is represented by one line on the chart, with the coordinates for both sides of the feature being listed on the one line. Lighttower hopes that the information presented is more understandable and therefore more helpful to the Commission. Other than the reorganization and reformatting, the substance of the lists remains as stated in the narrative accompanying the June 1 filing.

Lighttower also respectfully requests (and, to the extent necessary, respectfully moves) that these revised lists be accorded confidential treatment on the same grounds as set forth in the Motion for Confidential Treatment filed on June 1st. The discussion contained in the June 1st motion applies with equal force to the same substantive information contained in the lists being filed with this letter. Accordingly, Lighttower is filing both redacted, public and non-redacted, confidential versions of the lists. The confidential versions are in a separate, sealed envelope.
