## MOTION FOR WAIVER OF RATE CASE FILING REQUIREMENTS

NOW COMES Lakes Region Water Company, by and through Upton & Hatfield, LLP, and moves to waive certain filing requirements as follows:

- 1. Puc Rule 201.05 provides for waiver of the Commission's rules in cases where:

  "(1) The waiver serves the public interest; and (2) The waiver will not disrupt the orderly and efficient resolution of matters before the commission".
- 2. The Commission grants requests waivers when "(1) Compliance with the rule would be onerous or inapplicable given the circumstances of the affected person; or (2) The purpose of the rule would be satisfied by an alternative method proposed." *Id*.
- 3. Lakes Region requests that the Commission waive the requirement to file certain schedules and other information that the Company does not ordinarily maintain and is not required to maintain by law or rule, set forth below. This information would be time consuming and onerous to prepare. The costs to prepare the schedules would be unreasonable for both the Company and ultimately to its customers.
- 4. As an alternative, the Company expects that relevant information can be provided through discovery.

5. The Company requests that the Commission waive the following requirements for a Full Rate Case Filing under Puc 1604.01.

(1) Internal Financial Statements	The Company does not produce monthly financial statements.
(2) Annual Reports to Stockholders	The Company does not prepare Annual Reports to Stockholders
(6) Advertising	The Company did not incur any advertising expense.
(7) Cost of Service Study	The Company has never had a cost of service study performed.
(9) Chart of Accounts	The Company utilizes the PUC uniform system of accounts.
(10) SEC 10K and 10Q	The Company does not prepare the SEC 10K and 10Q.
(12) Depreciation Study	The Company has not conducted a deprecation study performed.
(13) Any Audits or Studies	The Company has not been involved in a management and / or financial audit.
(15) Officers / Executive Incentive Plans	The Company does not have any officers or executive incentive plans.
(18) Non-Utility Operation	The Company has no non-utility operation.
(20) Quarterly Income Statements 5 years	The Company does not generate quarterly financial statements.
(24) Short-Term Debt	The Company has no short-term debt.
(25) Subsidiary	The Company is not a subsidiary.
