Procedural Schedule

To the Parties:

The Commission held a duly noticed prehearing conference in the above referenced matter on September 30, 2015. Appearances were entered by Justin C. Richardson, Esq., for Lakes Region Water Company, Susan W. Chamberlin, Esq., for the Office of Consumer Advocate, and Rorie E. Patterson, Esq., for Commission Staff. Intervenors in the proceeding were, Douglas L. Patch, Esq., for the Property Owners Association at Suissevale, Inc., Murray D. Movitz, pro se, for residents of Judges Road, Thornton, William Endres, pro se, for Indian Mound Property Owners Association, (Attorney Gary E. Blais not present), Mark Evitts, pro se, for residents of Hidden Valley.

The Commission's attorney, Michael J. Sheehan, Esq., presided as the Hearings Examiner and, on October 6, 2015, filed a report summarizing his recommendations. The Commission has approved the recommendations in the Hearing Examiner's report and made the following determinations:

The customers and customer associations are granted full party status pursuant to RSA 541-A:32, I (b). The Commission directs the intervenors to participate through a single representative and to collaborate amongst each other to the greatest extent possible.

The Commission granted LWRC's request for waiver of N.H. Code of Admin. Rules Puc 1905.01 (a) (requiring a detailed description of rate case expenses actually incurred at the time utility files its rate case). Puc 201.05 allows the Commission to waive the filing deadline in Puc 1901.05 (a) in circumstances where "(1) The waiver serves the public interest; and (2) The waiver will not disrupt the orderly and efficient resolution of matters before the commission." The information required by rule was not available at the time of filing, and the Company has provided or will provide it when it is available.

The Commission has denied Attorney Blais's motion for admission pro hoc vice. Puc 203:16(a)(2) allows "an attorney authorized practice in any state or the District Columbia" to appear before the Commission. Mr. Blais is admitted in Rhode Island. Therefore, it is unnecessary for the Commission to permit his pro hoc vice participation.
