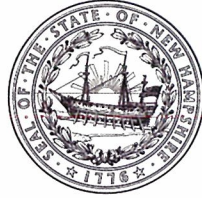

On July 30, 2015, the Commission held a duly noticed prehearing conference in the above referenced proceedings. Appearances were entered by NHSolarGarden.com, LLC, New Hampshire Sustainable Energy Association, Borrego Solar Systems, Inc., ReVision Energy, LLC, Freedom Logistics, LLC d/b/a Freedom Energy Logistics, Clifton Below on behalf of One Court Street Associates, Vital Communities, Energy Emporium, Erik Russell, Hana Masecar and Marie McCormick, The Alliance for Solar Choice, Public Service Company of New Hampshire d/b/a Eversource Energy, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities, Unitil Energy Systems, Inc., the Office of Consumer Advocate and Commission Staff. There were no objections to the intervention requests. The Commission has granted the petitions to intervene of the above parties.

Following the prehearing conference, Staff filed a letter reporting that the parties made progress toward an agreement for managing the net metering queue during the technical session following the prehearing conference and agreed upon the following schedule for technical sessions:
