**Examination of Electric Distribution Utility Interconnection and Queue Management Processes for Net-Metered Customer-Generators** 

## PETITION FOR INTERVENTION OF FREEDOM LOGISTICS LLC

NOW COMES Freedom Logistics, LLC d/b/a Freedom Energy Logistics ("FEL") hereby petitions the New Hampshire Public Utilities Commission for intervention in the above-captioned proceeding pursuant to RSA 541-A:32 and NH Code Admin. Rule Puc 203.17. In support of its Petition for Intervention, Petitioner says the following:

- 1. The Commission opened this proceeding with an Order of Notice on July 7, 2015 for the purpose of examining on a generic basis the customer-generator interconnection and net metering queue management procedures of the electric distribution utilities to examine on a generic basis the customer-generator interconnection and net metering queue management procedures of the electric distribution utilities, and potential modifications to these procedures to achieve uniform, just, and reasonable processing of customer-generator applications in the context of the strong and growing interest in utility net metering programs.
- 2. Petitions for Intervention, pursuant to RSA 541-A:32 and Rule Puc 203.1, must set for the facts demonstrating that the petitioner's right's, duties, privileges, immunities, or other substantial interests may be affected by the proceeding, and that the interest of justice and the prompt and orderly conduct of the proceedings would not be impaired by allowing the intervention. Alternatively, the Commission may grant intervention in the interest of justice so long as the intervention "would not impair the orderly and prompt conduct of the proceedings." RSA 541-A:32, II.
- 3. FEL is a licensed aggregator in five New England states specializing in providing management services to end-users that are Market Participant End-Users (MPEU). An MPEU is a member of NEPOOL and ISO-NE that purchases electricity directly from the ISO-NE hourly wholesale market. Freedom Logistics pioneered the adoption of dynamic pricing in New England.

There are currently numerous MPEU's located in New Hampshire that are clients of FEL.

- 4. FEL is currently working with renewable energy producers to develop further opportunities in New Hampshire that go beyond the existing net metering cap and interconnection issues, and seeks to develop a solar program that leads to a stable, equitable and self-sustaining solar market.
- 5. For the foregoing reasons, FEL has substantial interests that will be affected by the Commission's deliberations in this proceeding. FEL's intervention would also be in the interests of justice and the prompt and orderly conduct of the proceedings would not be impaired by allowing the intervention.

WHEREFORE, FEL hereby respectfully requests the Commission to grant it intervener party status and to order such other and further relief as may be just and equitable.
