**AUTHORIZATION FOR CLASS IV RENEWABLE ENERGY  
CERTIFICATE (REC) ELIGIBILITY**

The Commission received and staff reviewed the application requesting Class IV REC eligibility for the Squam River Power facility, managed by Andrew P. Lane and operated by Gerry Brooks. Based on Staff's recommendation, the Commission has approved the 0.39 megawatt facility as eligible for Class IV RECs,<sup>1</sup> effective as of September 14, 2015.
