Filing to Reflect Changes in Lifeline Obligations for Resold Lines

TO: Debra Howland, Executive Director

On August 5, 2015, Northern New England Telephone Operations LLC d/b/a FairPoint Communications – NNE ("FairPoint") submitted a letter and tariff page reflecting changes to its Tariff No. 4 for Resale Services.

As FairPoint noted in its letter, the Federal Communications Commission (FCC) has revised its rules regarding the obligation of incumbent local exchange carriers (ILECs) such as FairPoint to provide a discount to competitive local exchange carrier (CLEC) resellers serving Lifeline customers. In FCC Order 15-71, effective June 15, 2015, the FCC forbears from requiring ILECs to offer such a discount. The FCC had previously eliminated any requirement to support the LinkUp America program, and the revised tariff page also eliminated references to that.

FairPoint further noted in its letter that no CLECs were offering resold service to customers using the previously-offered Lifeline discount.

Puc 404.05 requires carriers such as FairPoint to maintain tariffs with the Public Utilities Commission (Commission) for wholesale service that is required under federal law or specifically referenced in interconnection agreements. In light of the FCC's Order 15-71, the resold Lifeline and LinkUp programs are no longer required under federal law, and to Staff's knowledge these services are not implicated in any interconnection agreements.

The FairPoint filing did not request Commission approval of the tariff changes, and the FCC action may perhaps mean the Commission had no authority to review them. To the extent that the Commission does have oversight of such tariff changes, the changes took effect under operation of law on September 4, 2015, pursuant to New Hampshire RSA 378:6, IV.

Staff recommends that this docket be closed.
