## **Summary**

This memorandum confirms Department of Energy (Department) approval for additional program budget allocations from the Renewable Energy Fund (REF) for fiscal year 2022 (FY22) as set forth in the Funding Allocations by Program (Table 2) on page 2. Further, the Department informs stakeholders of the following actions:

- The Department issued a Letter Order Modifying Program Application Processes on May 16, 2022. The letter order and staff recommendation regarding these changes are available at Renewable Energy Rebates | NH Department of Energy. Applicants should use the updated application forms available on program webpages that incorporate program application process changes approved in the order.
- Those projects currently on wait lists will be funded first and the balance of funds made available for new applications.
- The Department will continue to accept new applications for rebate programs until specific program funding allocations are fully utilized.
- Waitlists will be established for each Residential rebate program up to an amount of \$25,000 when the program receives applications in excess of its funding allocation.
- Waitlists will be established for each Commercial and Industrial rebate program up to an amount of \$50,000 when the program receives applications in excess of its funding allocation.
- No additional Requests for Proposals will be issued by the Department for renewable energy generation projects in the Non-Residential Sector (C&I Competitive Grant program) or for the Low and Moderate Income Community Solar Grant (LMI Grant program) programs, although additional funds will be made available for the LMI Grant Program to comply with RSA 362-F:10 X with total grant funding available noted in Table 2.

## **Funding Analysis**

Based on the REF FY22 Statement of Appropriation, \$2,000,000 was made available for allocation to FY22 grant and rebate programs. On September 3, 2021, the Department authorized the allocation of

\$1,000,000 to enable Department staff to open the rebate programs to new applications; with a second allocation of \$1,000,000 made on October 29, 2021.

The Department requested, and recently received approval from the Bureau of Accounting (BOA) to budget and expend an additional \$1,000,000 from the REF to reopen rebate programs to new applications.

This memorandum authorizes the allocation of that additional \$1,000,000. Table 1 below, presents the statutorily required funding breakdown between sectors.
