Dear Director:

Dated August 24, 2015, Town Square Energy received a Deficiency Letter pertaining to the renewal of its CEPS registration with the NHPUC. In addition to the August 24th letter, we subsequently received feedback from NHPUC Staff relating to shortcomings in our Terms of Service for residential and small commercial customers in New Hampshire. With today's filing, we wish to make available to the Commission all of the information and materials referenced in the recent correspondences between the NHPUC and Town Square Energy and required in order to complete the renewal of our CEPS registration.

Pertaining to the Deficiency Letter:

1. Item 1: Service Areas and EDI Certificates. Town Square Energy only supplies customers in the Unitil and Eversource territories. We do not currently, nor do we intend to during the renewal term of our CEPS registration, serve customers in NHEC or GSEC. Additionally, we have included with this filing an updated EDI certification from Unitil that specifies Town Square Energy as the registered party. This certificate replaces the version filed with the NHPUC on August 20, 2015.
2. Item 2: Financial Security. Included with this filing is proof of security in the form of updated bond documents.

Pertaining to the NHPUC Staff feedback we received relating to our Terms of Service:

1. An updated version of our Terms of Service was provided to Staff on September 16, 2015 and we received indication on September 17, 2015 that the updated version met
