On August 31, 2015, you filed with the Commission a complaint against Public Service Company of New Hampshire d/b/a Eversource Energy, after which Staff scheduled a hearing in the matter. On January 19, 2017, Staff filed a recommendation that the docket be closed inasmuch as you had communicated your desire to resume payment on the remaining HPwES loan balance. On January 28, 2017, you filed a formal request to withdraw your complaint.
