## PETITION FOR ADJUSTMENT OF STRANDED COST RECOVERY CHARGE FOR EFFECT ON JANUARY 1, 2016

Pursuant to Puc 202.01(a) and Puc 203.06, Public Service Company of New Hampshire d/b/a Eversource Energy ("Eversource" or "the Company") hereby petitions the New Hampshire Public Utilities Commission ("Commission") for a proceeding to establish a Stranded Cost Recovery Charge for effect on January 1, 2016 pursuant to the requirements of RSA 374-F:3 and RSA 369-B:3 and the Agreement to Settle PSNH Restructuring (Revised and Conformed) in Docket No. DE 99-099 ("Restructuring Settlement"). In support of its Petition, Eversource says the following:

1. The Stranded Cost Recovery Charge ("SCRC") was established under the Restructuring Settlement, and originally capped at an average of 3.40 cents per kilowatt hour. Once the Part 3 Stranded Costs were fully collected, the Restructuring Settlement provided that the SCRC would be set on a forecasted basis every six months and would include any over- or under-recovery of Part 1 and Part 2 stranded costs from the previous period. Restructuring Settlement at 25.

2. In Order No. 24,641 (June 30, 2006), the Commission approved the reduction of the SCRC rate from 3.35 cents per kilowatt-hour to 1.55 cents per kilowatt-hour on average beginning July 1, 2006 to reflect the complete recovery of Part 3 Stranded Costs. The Part 1 costs were fully amortized in 2013 and the final disposition of the funds relating to the Part 1 costs were reviewed in Docket No. DE 14-120 relating to Eversource's reconciliation of its 2013 energy service and SCRC costs. On September 18, 2015, the Commission issued Order No. 25,815 (September 18, 2015) which, among other things,

ruled upon the final disposition of those funds and permitted the Company to recoup certain of those funds. Consistent with Order No. 25,815, the recoupment of those funds is included in the calculation of the proposed SCRC rate in this docket and will be included in the calculation of the SCRC rate that is ultimately authorized by the Commission for implementation.

3. In Order No. 25,742 (December 29, 2014) in Docket No. DE 14-236, the Commission approved an average SCRC rate for effect on January 1, 2014 of 0.110 cents per kilowatt-hour. Pursuant to Order No. 25,791 issued on June 25, 2015 in the same docket, PSNH is currently billing an average SCRC rate of 0.155 cents per kilowatt-hour for the period July 1, 2015 through December 31, 2015.

4. Enclosed with this Petition are the pre-filed testimony, attachments and exhibits of Christopher J. Goulding supporting a change in the average SCRC rate. Based upon the data contained in those attachments and exhibits, Eversource currently estimates an average SCRC rate for effect on January 1, 2016 of negative 0.017 cents per kilowatt-hour. This estimated rate is a decrease of 0.172 cents per kilowatt-hour from the current average SCRC rate, which is primarily attributable to lower forecasted over-market IPP costs and the change in credits attributable to the refund of money associated with the Regional Greenhouse Gas Initiative pursuant to RSA 125-O:23, II and Order No. 25,664 (May 9, 2014). Eversource is not requesting approval of a specific rate at this time, but the Company will update its estimates with more recent data before a hearing on the merits is held in December.
