On April 1, 2016, the Commission held a duly noticed prehearing conference in the above referenced matter. Appearances were entered by Northern Pass Transmission LLC, Eversource Energy, and Commission Staff. The Office of Consumer Advocate has a statutory right to participate but chose not to at this time. The pending motions to intervene of the Town of Franconia and the City of Concord were taken under advisement.
