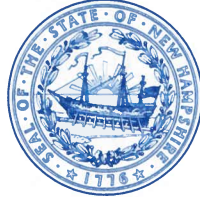

Petitions to Intervene

To the Parties:

On April 25, 2016, petitions to intervene were filed in this docket by the Franconia Community Church of Christ and Campbell McLaren, MD. No objections to the intervention requests were received. On May 18, 2016, a late-filed petition to intervene was received from Kris Pastoriza purportedly on behalf of the Easton Conservation Commission ("Easton CC"), to which Northern Pass Transmission LLC (NPT) objected on May 20, 2016.

The Commission has granted the petitions to intervene filed by the Franconia Community Church of Christ and Dr. McLaren. The Commission has denied Easton CC's request for intervention inasmuch as Ms. Pastoriza has not demonstrated that the Easton CC has the statutory authority to participate in this matter nor does Ms. Pastoriza qualify as an intervener under any provision of law, pursuant to RSA 541-A:32, I (b).
