To the Parties:

On April 21, 2016, the Society for the Protection of New Hampshire Forests (SPNHF) filed a late petition to intervene, claiming that it owned property that is affected by Eversource's a proposed crossing over the Connecticut River in Clarksville, New Hampshire. On April 21, 2016, Eversource filed an objection to the petition stating that it is not seeking a license to cross the Connecticut River because it is not relocating lines at that location. The crossing maps filed with the Commission confirm the veracity of Eversource's statement. Based on the foregoing, the Commission finds that SPNHF has not stated a right, duty, privilege or interest in the petition, and has not presented any information to support its intervention as a matter of justice. Therefore, SPNHF's petition to intervene has been denied.
