Dear Ms. Griffin:

On August 23, 2017, you filed on behalf of ENGIE Resources LLC (ENGIE Resources), a surety bond dated August 18, 2017 in the amount of \$350,000 (New Bond), intended to replace the surety bond dated November 19, 2015 and filed with the Commission on November 23, 2015 (Old Bond), as amended by a rider filed on October 27, 2016, which changed the named principal under the Old Bond from GDF Suez Energy Resources NA, Inc. to ENGIE Resources LLC.

The New Bond is in the amount of \$350,000, names the Commission as obligee, and has a term that may not be cancelled prior to April 18, 2021, the same as the earliest cancellation date of the Old Bond. Staff reviewed the New Bond and determined its material terms and conditions are acceptable, as confirmed in Staff's memorandum dated August 24, 2017.

Please be advised that the Commission has approved your request to use the New Bond as financial security for ENGIE Resources, in replacement of the Old Bond. Accordingly, the New Bond is accepted as financial security for ENGIE Resources.
