Dear Ms. Cammarano:

On May 4, 2016, Viridian Energy, LLC (Viridian) requested a waiver of Puc 2003.04(h) and an extension to June 1, 2016 of the review period for its application to register as a competitive electric power supplier (CEPS), which currently expired on May 1, 2016. In its request, Viridian stated that it is requesting the extension to ensure ample time to complete the application filing, pending any further issues and/or requests, and to either provide an amendment to its current surety bond or to replace its current surety bond with a new bond with an earlier term commencement date.

Commission Staff filed a memorandum on May 5, 2016, recommending the Commission approve the request for rule waiver and review period extension.

The Commission has reviewed Viridian's request and Staff's recommendation and has granted the request for waiver of Puc 2003.04(h) and for an extension of time, until June 1, 2016, for the review period of Viridian's application to register as a CEPS. Accordingly, Viridian's application review period is extended through June 1, 2016.
