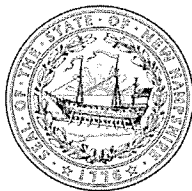

Dear Ms. Cote:

On November 19, 2015, the Commission received applications prepared by NhSolarGarden.com, LLC, requesting Class II renewable energy certificate (REC) eligibility certification for the Salmon Falls Holding, LLC (Salmon Falls Holding) project, and the Crocketts Crossing, LLC (Crocketts Crossing) project, pursuant to RSA 362-F:4 and New Hampshire Code of Administrative Rules Puc 2500. Staff has reviewed the applications and has found that the following additional information and clarifications are required in order to complete the applications for the Commission's eligibility review:

1. Puc 2505.02(b)(8) requires that applicants provide the name and contact information of the independent monitor (IM) for the project. Not only do your applications not list the IM, but the owner has agreed that he has certified to the IM that the meter operates according to manufacturing standards. Please explain or rectify this inconsistency for both applications.
2. Puc 2505.02(b)(5) requires applicants to provide the GIS facility code. Contact information to acquire the GIS facility code is provided on the application form. Contact James Webb, Registry Administrator, 408-517-2174, or email him at jwebb@apx.com, for information on how to obtain a GIS facility code number.

The Commission seeks to clarify these issues to ensure that the record supports a determination regarding the Salmon Falls Holding and Crocketts Crossing projects'


