**AUTHORIZATION FOR RENEWABLE ENERGY CERTIFICATE
(REC) ELIGIBILITY**

On January 13, 2016 the Commission approved the NhSolarGarden.com application requesting Class II REC eligibility for the Hank Brandt - Salmon Falls Holding, LLC photovoltaic (PV) array. Subsequently, Staff determined that the facility shared a revenue grade production meter with another facility. Additionally, the independent monitor (IM) had not completed an initial on-site verification of the system. Staff requested that the GIS withdraw REC eligibility until these issues were resolved. On April 12, 2016, the IM verified that an additional certified revenue grade production meter was installed and operating specifically for this facility.

In addition, the facility owner requested a transfer from NhSolarGarden.com to Knollwood Energy for aggregation and management of REC services. The Commission received a letter from Knollwood Energy requesting this transfer on June 17, 2016.

Based on Staff recommendation, the Commission hereby approves the PV array as eligible for Class II RECs effective as of April 12, 2016, the date the IM verified the system. The Commission also approves the transfer of aggregation services to Knollwood Energy.
